	Staffing levels: atleast two cargo staff (who have undergone training in basic cargo - IATA/FIATA Basic course as well as in the handling of Dangerous Goods plus expertise in sales and/or service including reservations, AWB issuance, shipment tracing, etc.) and one account administration staff with ability to handle accounting matters with good awareness of local government requirements and familiarity with airline billing and collection procedures.

A company with wider coverage in theassigned territory will have an advantage.	Provide complete details of branches/outlets including complete addresses and telephoneinformation. Photographs ofinteriorandexterior ofoutlets shouldbesubmitted.
